- The Steering Committee met following the Needs Assessment/Feasibility Study
 presentation by Justice Planners. The topics on the agenda for the meeting were specific to
 the Needs Assessment/Feasibility Study and Communications related to the Public Input
 Period.
 - A. Alan & Patrick attended the first portion of the committee meeting to debrief from the presentation and to specifically address the concern that was brought up about the Incarceration Alternatives. Patrick noted that the report indicates that the range of inmates eligible for EHM is between 8% and 33% of the population. This figure is dependent on everyone having perfectly clean criminal histories and based on what the Judiciary will allow. Pre-trial could also be an area to explore and could have an impact on the jail population if changes can be made.
 - B. James H was online to discuss the communications during the Public Input period starting tomorrow. The website will be updated with two options for comments. One button will be to make general comments and the other will be to take the survey. Hyperlinks will be

added to the survey to bring respondents to the report. The survey questions related to the seven alternatives will be moved towards the end of the questionnaire. The Finance Committee will meet following this meeting to work through the language related to what can be financed through a local option sales tax. For consistency "Jail" will be utilized instead of "detention center' and "services" will be used instead of "programming." Other minor changes to the Survey will be incorporated and the plan is to make this "go live" by the end of the day tomorrow (8/25/22). Survey responses will be provided to the commissioners at the 9/22/22 meeting for their review.
