

2022 NOTICE OF OFFICES TO BE FILLED AT THE STATE GENERAL ELECTION

To the Residents of the County of Beltrami, State of Minnesota:

The following is the notice of federal, state and county offices that will be voted on at the state general election to be held on Tuesday, November 8, 2022. The filing period for these offices begins at 8:00 a.m., Tuesday, May 17, 2022 and ends at 5:00 p.m., Tuesday, May 31, 2022.

Note: Filing offices will be closed Monday, May 30, 2022, in observance of Memorial Day.

**The place of filing in person or by mail is:
Federal Offices -file with the Secretary of State.
State and Judicial Offices- file with the Secretary of State OR
County Auditor of the County in which the candidate resides.
County Offices file with the County Auditor-Treasurer.**

Candidates may file in person or by mail, if the filing is received during the filing period. Candidates who will be absent from the state during the filing period and meet the requirements of Minnesota Statutes section 204B.09, subdivision 1a, may arrange to file during the seven days immediately preceding the candidate's absence from the state. This notice is sent based on current law. Be aware that the Legislature and/or Governor could make changes that affect some of these processes.

If the candidates reside in different counties, they must file with the Secretary of State.

A Candidate filing for one of the Minnesota Court of Appeals seats that has been designated for one of the congressional districts must be a resident of that congressional district.
