1. Introductions

Scott Fettig & Danielle Reid from Klein McCarthy Architects (KMA) attended their first Steering Committee meeting in person and were introduced to the Committee Members. The agenda for the meeting was to gather information from the Committee related to the tasks that they have been working on for the Jail Project over the course of the last year and a half. Notes taken by KMA are included as an attachment to these meeting minutes and in most cases expand on the topics noted in these minutes.

2. Site Due Diligence

Ben M updated the committee on the soil borings, Phase I Environmental and Phase I Archeological proposals that were received and have been approved allowing investigations to begin on the site. All will take place in the timeframe needed for the closing. KMA has been working with their Civil Engineers to have the documents completed for the CUP ahead

of the 6/30 deadline. KMA has produced a few site options to show how the site might be utilized for inclusion in the CUP submittal. (attached)

3. Public Communications

Tom B was at a meeting with the Chamber this morning and was not able to attend the meeting. Mayor Prince undated the committee on questions he's been getting from concerned citizens since the property selection was made public. The County announced that there will be a public hearing related to the site selection at the regular commission meeting next Tuesday, June 20th. Tom B and Sheriff Riggs will be meeting with Lakeland News later today to announce this meeting and to invite the public to attend and be heard.
