Keep it Clean Program



Like many Minnesota lakes, Upper Red Lake has seen a dramatic increase in winter activity over the past decade. The increase in popularity of ice fishing has grown quickly with technology, better equipment, and wheelhouses, which make staying on the ice for extended periods of time more comfortable. With this increased activity comes more pressure on the natural resources, including an increase in the amount of garbage and waste left on the lake. In an effort to reduce waste left of the ice, Beltrami Soil and Water Conservation District (SWCD) has formed a partnership with the Upper Red Lake Area Association and the Red Lake Watershed District to develop and implement the Keep It Clean Program on Upper Red Lake. This program is a public information initiative aimed at educating the public on responsible winter angling waste disposal.

Through a series of grants and donations, this partnership has been able to launch various media campaigns, provide human waste disposal sites at several lake accesses, and post advertising about proper waste disposal. Most recently, the SWCD received a Minnesota Pollution Control Agency grant to help launch a statewide effort to reduce the amount of waste left on Minnesota lakes. This grant allowed us to purchase a Keep It Clean wheelhouse to use as a mobile public education facility at fairs and fishing-related events. This display has already been at the Minnesota State Fair and the St. Paul Ice Show.

Beltrami has been working with other SWCDs as part of a larger, statewide effort to promote the Keep It Clean message to the public and encourage lawmakers to take action in preventing winter ice waste. One major result of this effort is a new 2023 law that prohibits the storage of garbage and other waste on the ice.

Auditor-Treasurer's Office Where We Are and What We Do

Beltrami County Auditor-Treasurer's Office is made up of four distinct areas, Property Tax Administration, License Center, Election Administration and County Finance. All functions are located in the County Administration Building at 701 Minnesota Ave NW, Bemidji. Building hours are Monday through Friday, 8:00 to 4:30.

Property Tax Administration: The property tax process consists of calculating the tax rate for all taxing authorities within the County, sending out the billing statement for all parcels, collecting the tax payments, and settling the collections to the respective taxing authorities. License Center: This office handles the processing of County Business Licenses, Vital Statistics, Minnesota DNR Registrations & Renewals, Minnesota Driver's License Renewals, and Department of Motor Vehicle Title Transfers & Tab Renewals. Election Administration: There are 27,500 Registered Voters and 61 Election Precincts in Beltrami County. Highway Department

Construction & Maintenance of Over 750 Miles of Road

The Beltrami County Highway Department is responsible for the construction and maintenance of over 750 miles of County roads, with approximately 400 miles of those being paved. To help provide an efficient paved road system Beltrami County utilizes a pavement management program. Within our PM program we prioritize investments on roads when deterioration is still minimal, extending the life of the pavement and avoiding the need for higher cost investments. Preventative type projects such as chip seals are prioritized because pavement life is extended more effectively versus higher cost complete resurfacing projects. For example, a chip seal costs \$35,000/mile and it lasts or extends the life of the road by 7-10 years, so each year of life costs \$5,000. A complete resurfacing project costs \$400,000 and lasts 30-40 vears, so each year of life costs \$13,000. Investments in our roads are prioritized, we do not use a worst-first method. A common question we receive is "why are we not working on road X, the worst road in the county?" The answer, as explained above, is we are prioritizing investments. However, Beltrami County is addressing the "worst" roads as funding allows. In the next 5 years we plan to improve 31 of the 42 miles of roads in poor condition. We will be getting to many of the "worst" roads. Overall, pavement condition is improving in the County, as shown in the included Pavement Condition chart. ~Submitted by: Highway Engineer, Bruce Hasbargen

New Marijuana Laws

Minnesota legalized cannabis use.... sounds pretty straight forward, doesn't it? Well it is far from that. There is a lot involved in the 300 plus page piece of legislation, which will likely be subject to court interpretation and future legal findings. This article will touch on several of the more substantial pieces of the law. Here is what we know:

On 08/01/23, Minnesota legalized adult use of cannabis. An adult may now legally possess or transport two ounces of green cannabis "flower" or eight grams of cannabis concentrate in public, including in their vehicle. The amount jumps to two pounds or 160 grams in their residence. Up to eight cannabis plants with no more than four being "mature" may be grown at a single residence.

However, persons under 21 may not legally use or possess cannabis, nor can adults smoke it around minors. Cannabis may not be used in motor vehicles, and there is an "open container" law very similar to the "open bottle" law for alcoholic beverages. Cannabis that is being transported in a motor vehicle must be in its original packaging or packaging that meets the requirements identified in the statute. It is also still illegal to use or possess on school property, in correctional facilities, or while carrying a pistol or possessing a firearm.

One piece of the legislation that has been misinterpreted is that it is not legal to use cannabis in public. Smoking or vaping cannabis is prohibited in location protected by the Clean Air Act and in multifamily housing.

Lastly, and most importantly, cannabis use impairs important skills required for driving by slowing reaction time and ability to make decisions, impairing coordination and distorting perception. Driving under the influence is not only dangerous but also illegal. Beltrami County deputies are on the lookout for under the influence drivers.

Rise in Opioid Related Issues

To say there has been a rise in opioid seizures in Beltrami County and the surrounding jurisdictions would be an understatement. The Beltrami County Sheriff's Office and Bemidji Police Department are partners in the Paul Bunyan Drug Task Force (PBDTF), a multi-jurisdictional drug enforcement team that includes Cass County, Hubbard County, Koochiching County and Mahnomen County along with White Earth Police Department, Leech Lake Police Department, Park Rapids Police Department, and the Bureau of Indian Affairs.

Statistically, evidence of opioid use and seizures have risen at a higher pace than any other drug for PBDTF. Over the past six years the seizure of opioids has risen steadily and significantly. Opioid use prior to 2014 was basically non-existent, with the total seizures in 2012 and 2013 being around 10 grams each. In both 2014 and 2015, significant seizures were conducted in Beltrami County which skewed statistics for those years with a seizure of 1,150 grams in 2014 and a seizure of 2,270 grams in 2015. It was apparent that after 2015, opioids were in the area to stay. From 2014-2019 seizures were primarily heroin. In 2019 and 2020, agents began to seize fentanyl at the same rate as heroin. Since 2020, heroin has been a rarity, with almost all seizures being fentanyl. The ten-year increase of heroin/fentanyl from 2012 to 2022 was an astonishing 28,500%.

The evidence of opioid use can also be seen through the drastic increase in overdoses which is shown on the included graph. As tragic as the statistic in the graph may appear, they do not paint a full picture of the devastation that opioids have brought to Beltrami County as they do not include overdose statistics from the Red Lake Police Department which, if included, would add 14 additional fatal overdoes to 2022.

Let this sink in...42 people died last year in north-central Minnesota of opioid related overdoses. These 42 people came from every walk of life and leave behind a wake of tragedy and often an abundance of unanswered questions. These people were children, parents, siblings, aunts, uncles, friends and neighbors all of whom shared the common denominator of addiction.

Cases involving overdose deaths are treated as murder investigations and have been taken seriously by the Beltrami County Attorney's Office. In 2023, The Beltrami County Attorney's Office has successfully convicted four individuals for 3rd Degree Murder for causing a death of a human being by providing them with a controlled substance. Several other cases are progressing through the court process.



If you or a loved one are suffering from an opioid addiction, please seek help. We realize that we cannot arrest our way out of this problem, but the men and women of the Beltrami County Sheriff's Office, Bemidji Police Department and the Paul Bunyan Drug Task Force are working tirelessly to seek out those individuals responsible for bringing this poison to our area.

Bemidji Veterans Home Progress and Anticipated Opening

The Bemidji Veterans Home is scheduled to open on Tuesday, January 16th, pending some finishing touches with construction, surveys, and occupancy certification. If these items are completed as expected, admission staff will begin admitting 4 veterans per day for 6 working days until they reach their maximum starting capacity of 24 veterans. The home will then be required to pass a recognition survey from the Federal Department of Veterans Affairs within 30-60 days before admitting additional veterans and spouses, up to a max of 72.

Currently there is a waitlist of 275 individuals, including 232 veterans and 43 spouses, who are eager to be admitted to the home. The first 24 admissions will be selected chronologically, with those whom applied earliest getting the first opportunity. Admissions will also be required to meet eligibility requirements for long-term care. This means that estimated wait times for those on the list cannot be provided, as admission is dependent on a variety of factors that are federally regulated. Neither length of service nor medical conditions influence the waitlist or time to admission in any way.

In a recent conversation with Kevin Gish, the Administrator of the Bemidji Veterans Home, he mentioned that previous construction delays have allowed them to focus on recruiting a strong team. They have successfully hired the entire leadership team and are now actively seeking direct care nurses, aides, housekeepers, and food service staff. Various staff will start in December with others coming in January. Continued vacancies include positions for Certified Nursing Assistants, RNs, LPNs, Food Service Workers, and Housekeeping. If you or anyone you know is interested, please visit the Minnesota Careers Website to apply.

Building tours are not yet available but will be arranged for stakeholder groups and families on the initial admissions list in the coming months. A celebratory grand opening is planned for Spring 2024, which will include state legislators and community members.

Please note that the Bemidji Veterans Home staff are unable to accept donations due to space constraints at this time. They deeply appreciate the overwhelming generosity of the community and continued support as they work towards facility opening.

Winter Park Activities

It's that time of the year again...skiing, snowmobiling, and maybe some hot chocolate! Winter in Beltrami County is always a wonderful time full of activities and beautiful scenery. Here is what's happening in the parks this season:

Movil Maze Recreation Area is open for many different winter sports. The main ski trails are limited to cross-country skiing only (damaging groomed ski trails is prohibited under Administrative Rule 6100.1355), but we have also opened the mountain bike trails as ungroomed, non-motorized multi-use trails for walking, running, snowshoeing, fat-tire biking, or walking the dog. For motorized use, snowmobile trails travel through the north portion of Movil Maze. The shelter is open to help warm up after an exhilarating, but perhaps chilly, outing in the woods.

Three Island Park is our other hub for winter recreation. The Gold and Orange Trails located at the north trailheads of the park are groomed and open to non-motorized uses. You can ski, snowshoe, walk, run, and bike and pets are also allowed on these multi-use trails. All other ski trails (Red, Green, Blue, and Brown) are only for cross-country skiing. The snowmobile trail travels from the south end of the park, over the Turtle River, and to the very north tip of Three Island Park, onto Black Lake Rd NE. The shelter at the north trailhead near the scenic Turtle River is also open as a warming house and there are wood stoves at each shelter, so bring some food and hot chocolate to warm up after a day of enjoying the park.

Whatever winter activity is your favorite, get out there as often as you can and enjoy your parks!

Bemidji Regional Airport As the Beacon Rotates

Runway 13/31 Rehabilitation

This past summer the Bemidji Regional Airport Authority (Authority) completed a mill and overlay of runway 13/31 at the Bemidji Regional Airport (BJI). Runway 13/31 is BJI's primary runway as well as its most valuable asset. Maintaining its pavements to allow the airport to function safely and efficiently is a top priority. The Authority and Karvakko Engineering, Inc. began working with the Federal Aviation Administration (FAA) and Minnesota Department of Transportation (MnDOT) Aeronautics in 2022 to make this project a reality. Runway 13/31 is 7,004 feet long by 150 feet wide and was last reconstructed in 2007. The project was needed now to address a deterioration of the runway surface and to address the change in aircraft fleet to accommodate larger more frequent traffic. This project included the removal of the top two inches of bituminous, then placement of four inches of new bituminous thereby increasing the strength and extending its useful life at least for the next ten years. Total project cost was \$5.4 million. The project was funded primarily with a FAA's Airport Improvement Program (AIP) Entitlement and Discretionary grant at 95%. The FAA's AIP grant program is funded through the Airport and Airway Trust Fund which receives the vast majority of its funds from taxes generated within the national aviation system. Mn/DOT Aeronautics provided another 2.5% of the funds for the project through its grant program, which receives

the new bituminous and put down the permanent pavement markings. An interesting fact about the machine used to groove the runway is that each pass of the machine was approximately three feet wide so the machine had to make over 2,300 passes to groove the entire runway. The project took 29,200 tons of bituminous and over 66,000 square feet of paint.

The Bemidji Regional Airport, the 4th busiest commercial service airport in Minnesota, is owned by the City of Bemidji and Beltrami County and managed by the Bemidji Regional Airport Authority through a joint powers agreement. BJI has an economic impact of over \$57.7 million annually and either directly or indirectly provides over 460 jobs to the region.

Airport Zoning

Part of keeping every airport and the community it serves safe is ensuring that the land use surrounding the airport is compatible. Airports must have zoning approved by the Mn/DOT Commissioner to receive funding through Mn/DOT Aeronautics. Recent state legislation allowed airports to pursue custom zoning. Custom zoning allows an airport and its community a way to comply with airport zoning while ensuring the safety of the users of the airport and those on the ground around the airport with compatible economic development.

its revenues from the State Airports Fund, again primarily funded by users of the aviation system in Minnesota. The Authority's local share of 2.5% is funded through its capital levy.

The project began on July 24th when runway 13/31 was closed. Then on July 26th the airport was closed to all aircraft, except helicopters, to allow the contractor to work in the intersection of BJI's two runways. Closing the airport required upfront and ongoing coordination with all the users of the airport many months in advance and on a routine basis once the project started. Runway 7/25 was opened on August 2nd and air traffic resumed. Runway 13/31 remained closed until August 17th to complete the mill and overlay as well as temporary marking part of the project. The runway needed to be closed again September 5th through September 28th to groove

In 2022, the Bemidji Regional Airport Authority, the City of Bemidji, Beltrami County, Joint Planning Board, Bemidji Township, Grant Valley Township, Eckles Township and Northern Township formed the Joint Area Zoning Board (JAZB) for the Bemidji Regional Airport. The JAZB reviewed current airport zoning, which did not conform to Mn/DOT Aeronautics standard zoning and updated it. Currently, all LGUs and JAZB have passed resolutions in support of the draft Airport Zoning Ordinance. The draft Airport Zoning Ordinance has been submitted to Mn/DOT Aeronautics for review. The next step in the process will be to address any input and comments from Mn/DOT and then hold Public Hearings prior to the final adoption and implementation of the new Airport Zoning Ordinance.

Winter Safety

ICE SAFETY: The Beltrami County Sheriff's Office would like to remind everyone about the dangers of early ice. Despite the colder temperatures and ice forming, ice on Beltrami County waterways remains too thin to be safe. The Minnesota DNR's guidelines for new ice is 4 inch thickness for foot travel, 5 inches for snowmobile or ATV, 8-12 inches for a car or small truck and 12-15 inches for a medium truck. Always remember that ice is never 100% safe!

When venturing out onto the ice wear a lifejacket or float coat and use a weighted ice chisel to check the ice ahead of you while walking. Ice thickness throughout the lake can vary drastically such as one spot being 4 inches and only a few feet away being 1 inch thick. As always it is very important to talk with children and teens about the dangers of thin ice and cold water. Please remain vigilant of children of all ages while outside near all bodies of water whether ice covered or open.

Once the lakes fully freeze and ice fishing season is in full boom, remember, ice is never 100% safe! Make sure to pay close attention to the ever changing weather conditions to include snow storms that could get you stranded out on the lake. Be sure that sleeper fish houses have working smoke alarms and CO2 detectors. Inform someone where you plan to fish, route of travel and estimated time of return.

SNOWMOBILE SAFETY: Now is a good time to get those snow machines pulled out of storage and annual maintenance done before the hustle and bustle of the holidays. Take a look at your registration stickers making sure they're up to date. The Grant-in-Aid snowmobile trails open Dec. 1, 2023 thru Apr. 1, 2024 and users must purchase a Trail Use Registration sticker when operating on these particular trails. Keep in mind portions of these trails run through private property, therefore, remain on the marked trails to not jeopardize our ability to use private lands. A major complaint to law enforcement regarding snowmobiles each season is trespassing.

The Beltrami County Sheriff's Office strongly encourages every snowmobiler to practice 'Zero Alcohol' use as part of their safe riding habits. Operating a snowmobile while under the influence of alcohol, a controlled substance or its metabolite, or other hazardous substance is unlawful. An operator who is found to be impaired or has an alcohol concentration of .08 or more will be arrested for snowmobiling while intoxicated (SWI). If you are convicted or refuse chemical testing your driver's license will be revoked and your snowmobiling privileges will be suspended for one year.

The two major factors of snowmobile accidents are speeding and alcohol use. Let's have a safe and enjoyable snowmobile season by slowing down and 'Zero Alcohol.'

How to Plow a Driveway

The Beltrami County Highway Department would like to remind county residents that it is unlawful under Minnesota Statute 160.2715 to plow snow from driveways <u>onto or across</u> public roads. Piles of snow left on or near the road can freeze into a solid



mass or cause drifting, creating hazardous situations for vehicles and snowplows. Accidents and damages caused by snow piles placed in the roadway may result in liability to the property owner. The diagram below demonstrates the proper way to remove snow from driveways.

During the winter months and holiday season, there is a significant increase in residential fires. This is a result of the combination of people spending more time indoors,

heating sources, holiday decorations and cooking. Make sure your furnace is maintained and serviced to ensure it is operating properly as well as for efficiency. If you have a fireplace, make sure your chimney is properly cleaned to reduce the risk of fire. Keep combustible materials at least three feet from flame and heat sources.

Holiday activities also contribute to residential fire risk. If you are using holiday lights, do not overload outlets and extension cords. If you have a real tree in your home, make sure it's adequately watered so it doesn't dry out. Dry trees can ignite and turn into a fiery inferno in seconds, enveloping a room with flames. Remove the tree from your home when needles are brittle or begin to fall off. Do not position your tree where it will block exits from your home. Keep candles away from flammable materials, and never leave them lit when you're sleeping or away from home.

When cooking, the Minnesota State Fire Marshall's Office recommends avoiding loose-fitting clothing that can easily catch fire and to stay in the kitchen when cooking. If a fire starts, put a tight-fitting lid on the pan and turn off the heat source. Keep flammable items like towels, wooden spoons and oven mitts three feet from the stove. Cooking fires resulted in an average of \$4.5 million in damage each of the last five years in Minnesota. Have a safe and enjoyable holiday season!

Beltrami County Economic Assistance Child Care Assistance Program

One of the programs of the Economic Assistance Division of Health & Human Services, is to determine qualified applicants for its Child Care Assistance Program.

The Child Care Assistance Program can help pay childcare costs for children up to age 12, and for children with special needs up to age 15. These costs may be paid for the time a parent is working, looking for work, going to school, or participating in activities that have been approved in a Minnesota Family Investment Program (MFIP) or Divisionary Work Program (DWP) employment plan. There is no time limit on how long you may receive childcare assistance, if you meet the requirements, and your income is within the limits for your family size. Your childcare must be provided by a legal provider who is at least 18 years old. To receive childcare assistance to help pay childcare costs you must be a parent, stepparent, legal guardian or eligible relative caregiver.

The committee hosted 2 community learning sessions in October and Sara Lovett provided the County Commissioners with local data at the November 21 board meeting.

Remodel:

The Family Health Clinic is currently undergoing a remodel project that will improve the space utilized by both the clients served and the Public Health staff. The remodel is expected to be complete in February 2024. There are signs posted to redirect community members to the temporary location of the Family Health Clinic, which is still on the first floor next to the original space in the Beltrami County Community Services Center. In September, Public Health hired a Community Health Nurse. This has resulted in the ability to build community partnerships that bring public health services to the people which addresses gaps in health equity. Examples include: Tuberculosis screening, an additional site for Woman Infants and Children (WIC) services, Immunization clinics, foot clinics, reviewing school immunizations for compliance, training school staff in Epi Pens and Narcan administration, response to seizures, and how to respond to general emergencies. In addition to providing these types of services, we have also partnered with Northwestern MN Juvenile Center, Sanford health, homeless shelters, and the Wellpath Staff at the jail. Free Service Alerts Property, Homeowners to Potential Fraud

Property Fraud Alert is an online subscription service offered to the public that allows them to have their name monitored within the Recorder's Office in order to track possible fraudulent recordings that affect their property.

The threat of mortgage fraud and identity theft crimes continue to rise, and all too often victims of these types of fraudulent activities are unaware their homes or identity have been stolen. While Property Fraud Alert does <u>not</u> prevent fraud from happening , it provides an early warning system for property owners to take appropriate actions should they determine possible fraudulent activity has taken place.

A common property fraud scenario involves a criminal filing a bogus deed making it appear the actual owner had transferred ownership to someone else. The criminal takes the deed to the bank, fraudulently obtains a
