RE: Agreement for Health Care Services - Contract Renewal and Staffing Adjustments

Greetings Sheriff Riggs:

I hope this letter finds you well. Wellpath is pleased to be your provider for quality health care services, and we are excited to move into another year of providing quality healthcare at the Beltrami County Jail.

Automatic Contract Renewal

Per section 9.0 of our underlying Agreement, our contract term shall automatically renew for an additional one-year period effective January 1, 2025, and ending December 31, 2025. Normally Wellpath would request a CPI increase consistent with the Consumer Price Index ("CPI") reported by the U.S. Bureau of Labor Statistics for All Urban Consumers – U.S. City Average, for Medical Care Services. The CPI for Medical Care Services is currently 3.1% for May of 2024.

Compensation Adjustment

However, the CPI for Medical Care Services does not accurately reflect the extreme inflation in the economy during the past year. For reference, the annualized percentage change in the Consumer Price Index ("CPI") for All Urban Consumers – U.S. City Average, for All Items was 4.2% for 2023 and was 8.0% for 2022.

These indices, reported by the Bureau of Labor Statistics, more accurately reflect overall inflation, and we propose using CPI for All Items for our contract escalation starting point. We must revise the contract amount to reflect the current market rates and to maintain the quality and standard of medical services provided to the patients. Therefore, we propose escalating the current contract amount by **5.0%**, effective January 1, 2025.
