2nd Quarter Narcotics Seizures and Purchases

For the quarter ending JUNE 30, 2025, the PBDTF seized and purchased narcotics totaling \$193,105:

- A combined total of 1,399 grams (3 pounds) of Methamphetamine, having a street value of \$76,945
- A combined total of 364 grams (0.8 pounds) of Fentanyl, having a street value of \$46,956
- A combined total of 866 Fentanyl pills, having a street value of \$15,588
- A combined total of 3,578 grams (7.9 pounds) of Marijuana, having a street value of \$4,740
- A combined total of 1,295 grams (2.9 pounds) of THC Wax, having a street value of \$38,850
- A combined total of 298 THC vaping cartridges, having a street value of \$9,834
- A combined total of 12 grams of Psilocybin mushrooms, having a street value of \$192
