
Housing **Trust Fund**

Addressing Housing Needs in Beltrami County

Year one of the Beltrami County Housing Trust Fund has laid the groundwork for impactful housing solutions. With initial funding allocations complete and development projects under review, Beltrami County Housing Trust Fund allocated funds totaling \$49,500 to two community housing programs aimed at providing safe and stable housing for individuals and families in Beltrami County.

Society of St. Vincent de Paul - Hope in Bemidji Program: St. Vincent de Paul has received funding to directly address the urgent housing needs of low-income individuals and families in Bemidji. With this grant, St. Vincent de Paul can act quickly – often within 24 hours – to meet with individuals, assess their needs, and provide immediate assistance to secure housing. This grant empowers St. Vincent de Paul to provide faster, more efficient support for new housing placements and crisis intervention.

BI-CAP - Affordable Housing Program: Bi-County Community Action Programs (BI-CAP) has been awarded funding to perform essential repairs on two critical housing units in Bemidji, enabling the organization to continue its mission of providing affordable, stable housing for

low-income families. Planned repairs include sheetrock replacement, painting and flooring upgrades, new fixture repairs, window, cabinet, and door replacements. The repairs will be carried out by a local contractor, supporting both housing stability and the local economy. This initiative will create safe and operational housing for homeless, low-income families working with local housing programs, helping them overcome significant barriers to economic stability.



This next phase of the Housing Trust Fund process focuses on allocating funds for housing development projects. The pre-application period, which ran from mid-November through the end of January, received six submissions. These pre-applications will now be reviewed by the Housing Trust Fund Cabinet. Selected applicants will be invited to submit full applications, which will undergo further evaluation to determine the allocation of development funds.

Beltrami County and The United Way of Bemidji Area remain committed to transparency,

collaboration, and strategic growth in addressing housing challenges throughout Beltrami County.

Beltrami County Environmental Services Department wants to remind citizens that permits are required for many activities such as constructing or placing new structures and earthmoving (such as putting in a driveway or hauling in fill for a future building pad) within 1,000 feet of lakes and within 300 feet of rivers.



Environmental Services staff are available to assist current and prospective landowners with tasks such as identifying if a permit is required, what entity is the correct permitting authority, and what the general standards are that must be met for your project. Life Safety Awards for Selfless Actions

2024 Upper Red Lake Ice Rescue

On January 11th, 2024 at approximately 5:10PM the Beltrami County 911 center received a 911 call of an adult male who had reportedly fallen through the ice on Upper Red Lake. Multiple agencies including Kelliher Fire & Rescue, Kelliher First Responders, Blackduck Ambulance, MN DNR Conservation and Beltrami County Deputies responded.

It was later learned that two males were coming off the lake from fishing when their Polaris Ranger side-by-side went through thin ice. The two men had been fishing on the lake with two additional men on snowmobiles. The group exhausted all efforts in attempting self-rescue. Richard Wieneke, an area employee of Greater MN rentals, was on the ice nearby and was found by one of the fishermen assisting. Richard, his brother David Wieneke and Carter Gilge from Greater MN Rentals responded to the scene.

One man had been able to extract himself from the Ranger through a window and was rescued first by David Wieneke and Carter Gilge. Upon pulling him from the open water, the other victim floated to the surface. Efforts to throw him a rope were initially unsuccessful due to his inability to grab the rope. It was estimated that he had been in the water for well over 20 minutes before being pulled out. Thankfully, both men were wearing float coats. The air temperature was approximately 0 degrees.

David Wieneke guided the group back to Greater MN rentals where they were assisted by Marlys Carlson who provided first aid and to keep the group warm while waiting for the Blackduck Ambulance to arrive.

One man was assessed and treated on scene and the other was transported by ambulance to Sanford Medical Center in Bemidji for hypothermia.

The actions of Richard Wieneke, David Wieneke, Carter Gilge, and Marlys Carlson ultimately saved the lives of these two men. The Beltrami County Sheriff's Office is grateful to those who selflessly acted for the preservation of life. Beltrami County Sheriff Jason Riggs submitted these efforts to the Minnesota Sheriff's Association as a life saving award in early 2024. The Minnesota Sheriff's Association awarded Richard Wieneke, David Wieneke, Carter Gilge, and Marlys Carlson the MSA Life Saving Award.

Deputy Ruport's level of training, professionalism, and life experiences made this an easy decision for Sheriff Riggs who placed Deputy Ruport in this role.

The position was created by Beltrami County Sheriff Jason Riggs in late 2024. Deputy Ruport took on this role in January 2025. Funding for this position was a direct result of Public Safety Aid Funding from the State of Minnesota in 2024.



Meet Riot

K-9 Partner

The Beltrami County Sheriff's Office has a storied K-9 history going back several decades. Throughout these years, all dogs were trained in drug detection, criminal apprehension, or both. In 2024, at the request of Deputy Alison Critchfield, the Sheriff's Office started exploring the idea of adding a dog to be trained in search and rescue. In the fall of 2024, Deputy Critchfield and Riot started patrolling together.

Riot, a four-year-old male Beauceron, and Deputy Critchfield, an 11 year Sheriff's Office veteran' were certified with the National Search Dog Alliance in Search and Rescue. Riot has been deployed several times already, looking for elderly individuals who have wandered away, individuals suffering mental health incidents, and people reported as missing or lost. A Search and Rescue dog differs from an apprehension dog by the way they find humans. While an apprehension dog smells odor left on the ground by the person they are tracking, a Search and

Rescue dog focuses on odor which is carried on the air currents. This is particular handy when looking for an individual but he area has already been searched by others who have left their own scent behind. The other difference is that Search and Rescue dogs are not trained to bite, eliminating the risk of injury during non-criminal searches.

Riot is also a certified therapy dog who spends time working with the local first responder's peer support team during critical incident debriefs. Riot is available to lend his calming demeanor and therapy skills during other portions of the criminal justice process.

When Riot is not searching for lost individuals or calming nerves, he enjoys interacting with the public, particularly students at area schools.

The Sheriff's Office now has a total of three K-9s.

Spring Recreation is Coming


To County Parks

The start of 2025 has been a little more wintery than last year. Luckily there has been enough snow for winter recreation, albeit a slower start than our normal northern winters. There is snow in the forecast and the little groundhog has predicted six more weeks of winter. But we all know spring is on the horizon, so let's take a look at what we accomplished last year and what we are looking forward to this spring:


- We completed the erosion repair project at the Mississippi High Banks campsite. Over many years, the sandy bank became unstable and eroded into the river. A set of stairs, bank stabilization, and vegetation was placed to restore the hillside. There is a platform at the bottom for access to the river and to tie up canoes or kayaks. This project was paid for with Enbridge and Mississippi Headwaters 1W1P grant funds.
- The bike workstation at Movil Maze should be installed this coming spring. A concrete pad was poured last fall but a

small delay with installation occurred (whoops...they forgot to send the hardware). With a Neilson Foundation grant, we were able to purchase the workstation, and picnic table, among other things. A big thanks to the George W. Neilson Foundation for their continued support at Movil Maze Recreation Area.

- A combination cross country ski and mountain bike stand was built by volunteers for Movil Maze. The stand was placed and is ready for use!
- Last but not least (we've been teasing this for years...), this May, we will be installing new concrete vault toilets at Movil Maze and the north and south trailhead at Three



Island Park. In 2023, we were awarded an American Rescue Plan grant to replace an aging restroom infrastructure. Finally, after two years, the project will come to fruition. The restrooms will be brought in on a semi and a crane will be used to put them in place.

Northern Warriors Outreach & Mobile Claims Unit

Expanded Veteran Services

Veterans in Beltrami County will soon have better access to the benefits and support they deserve, thanks to the launch of Northern Warriors Outreach (NWO). This groundbreaking initiative by the Beltrami County Veterans Service Office is designed to bring essential services directly to veterans wherever they are.

A major component of NWO is the upcoming Northern Warriors Outreach Mobile Claims Unit (NWOMCU), a first-of-its-kind mobile office that will travel to rural and underserved areas within Beltrami County to help veterans access their benefits, file claims, and receive vital healthcare navigation. The initiative is made possible through a \$180,000 grant from the Minnesota Department of Veterans Affairs (MDVA) Competitive Grant Process, ensuring that more veterans can get the assistance they need without the burden of long-distance travel.

Bringing Services to Those Who Need Them Most

For many veterans in Beltrami County, transportation challenges and remote locations have made it difficult to connect with essential services. The NWOMCU will remove these barriers by providing face-to-face support from trained CVSO representatives in key community locations.

While the Bemidji Veterans Service Office remains the primary location for veteran services, the mobile claims unit will allow staff to schedule times to bring these services directly to local communities, ensuring that veterans who cannot travel still receive the assistance they need.

Additionally, the Veterans Service Office will periodically collaborate with the MDVA Tribal Veteran Service Officer to expand resource opportunities for Native American veterans, ensuring that those who have served receive the support they deserve.

What the Mobile Claims Unit Will Provide

Once launched, the NWOMCU will serve as a lifeline for veterans by offering:

On-the-spot assistance with VA benefits and claims processing to speed up access to disability compensation, pensions, and healthcare.

Guidance on healthcare enrollment and services to connect veterans with the medical care they need.

Regular visits to rural and tribal communities to ensure all veterans have equal access to resources.

Proactive outreach to at-risk veterans, including those facing financial hardship, medical issues, or homelessness.

What's Ahead for Northern Warriors Outreach?

The Northern Warriors Outreach Mobile Claims Unit is currently in development, and preparations are underway to ensure it effectively serves veterans across Beltrami County. As the program moves forward, updates on its availability, community visit schedules, and additional service details will be shared through the Beltrami County website, County News Letter, and the Beltrami County Veterans Service Office.

Veterans and their families are encouraged to stay informed by following official announcements and checking for updates through the Beltrami County Veterans Service Office.

Right of Way Obstructions


Along County Roads

The Beltrami County Highway Department strives to provide a public right-of-way that is safe and free of hazards. At times, objects are erroneously placed in the right-of-way. Those objects are a safety hazard for vehicles that run off the road, which is the most common type of crash. Objects are also a hazard for operators of ATV's and snowmobiles. Minnesota Statute 160.2715 prohibits placing objects in the road right-of-way. Examples of illegal objects are fences, signs, billboards, political signs, retaining walls, rocks, or any other items that may hinder passage.

The County is addressing any objects that are found to be within the road right-of-way. No new obstructions will be allowed, and any existing obstructions will be required to be removed by the owner within a reasonable timeframe.

The proposed recycling site location will be at 1917 Fern Street North, PIN: 800700200. This site will only be for Single Sort Recycling, and collection of lithium and rechargeable batteries.

This site will have one compactor instead of the current roll-off container, which will reduce the number of times the containers need to be emptied. Currently we service (empty) eight containers three times a week. The use of a compactor will reduce the amount we need to service to once a week. If needed, the site will have the capacity to add one more compactor in the future.

How is this site being paid for? The County was successful in applying for a Minnesota Pollution Control Grant and awarded a grant that will pay for 75% of the project. Without state grant help, the cost saving would have taken 2.5 years to pay for the site.

New Recycling Site Proposed

Beltrami County Solid Waste Division has been planning for and will be creating a new Recycling Site within the City limits. This site will replace both the Northdale Oil site and the Target site.

Why: The Northdale Oil site will no longer be accessible due to road construction planned for 2025, and the County is looking at selling

the Target location land sometime in the near future

Plans have been approved by the County Board and City of Bemidji and waiting on final approval from the Airport Authority/FAA since this location has limited use due to being in the airport authority jurisdiction.

SNAP-Ed

Supplemental Nutrition Assistance Program Education

SNAP-Ed is federally funded and administered by SNAP State and local implementing agencies. States conduct needs assessments to ensure that SNAP-Ed is delivered in a hands-on and tailored way for their communities. SNAP is the nation's first line of defense against hunger and a powerful tool to improve nutrition among people with low income. SNAP-Ed agencies should emphasize the importance of programming that addresses both food and nutrition security and should adapt all approaches they use to deliver evidence-based nutrition education and obesity prevention activities with an equity lens. We do this by serving the community members who qualify by offering Nutrition Education and Policy, System, and Environmental Change opportunities.

Nate Douglas has started programming with BI-CAP Head Start in both the Bemidji and Blackduck locations, teaching a nutrition curriculum called Harvest for Healthy Kids. Starting in the spring of this year, he is collaborating with the Kelliher Public Library on their community gardens. SNAP-Ed will be working with local families and

providing nutrition education during the scheduled events. Nate is continuing to build a relationship with a community partner and Joe Johnson of *Parenting Solutions* to create a new Men & Fathers class around healthy eating & cooking in Beltrami County.

This fall and winter, Eve Lavrenz has conducted nutrition education using a curriculum created by SNAP-Ed called "Go Wild" in thirdgrade classrooms at Kelliher Elementary and Lincoln Elementary. Plans include expansion to more third grade classrooms next school year. The goal is to engage all free & reduced eligible third-grade classrooms in Beltrami County, being intentional about serving the communities outside of Bemidji, such as Kelliher, Blackduck, and Red Lake. Additionally, Eve has been working closely with Evergreen Youth and Family Services to provide a youth/young adult cooking class with great success using a trauma-informed curriculum designed to promote community among participants. For summer of 2025, there are plans to collaborate with *Light My* Lotus, an organization that promotes active living, to start a multiorganizational effort to engage older adults and children in an outdoor walking club. This effort includes a variety of partnerships with Bemidji Park and Recreation, BSU, and Bemidji Early Childhood Collaborative.


Communication:

Spring Weight Restrictions

On County Roads

In the spring of each year, vehicle weight limits are put in place by road authorities to protect the significant investment that has been made in the road system.

When the ground thaws, the materials under the road surface become saturated and soft. With the reduced support from the underlying material, the road surface will bend and crack under heavier vehicles. On paved roads, the freezing and thawing of moisture in the cracks can deteriorate into potholes or additional cracking. On gravel surfaced roads, these cracks can turn into soft spots or even impassable roads.

Spring weight restrictions have proven to be essential in protecting roadways. Limiting the weight reduces the damage and further deterioration. The timing and length of the restrictions vary but usually start in Beltrami County around mid-March and last for approximately eight weeks. Unless posted otherwise, gravel roads are restricted to 5 tons per axle and paved roads are restricted to 10 tons per axle. Designated Minnesota Severe Weather Awareness Week

It may seem early to be thinking about severe weather and summer weather hazards, but spring is nearly here. Each year, Minnesota's Emergency Managers partner with the National Weather Service to promote severe weather preparedness. April 7-11, 2025 is designated Minnesota Severe Weather Awareness Week. There are daily topics to address the hazards Minnesotans face during the spring and summer months.

Monday's topic is alerts and warnings. When impactful weather is occurring, the National Weather Service may issue alerts and warnings. It is important to have several sources to receive this information. These alerts can include severe thunderstorms,

tornadoes and flooding. Watches mean conditions are favorable for the identified hazard and warnings indicate it is occurring or likely to occur. NOAA Weather Radios are reliable and the fastest way to receive warnings. There are also many different apps you can use on smart devices.

Tuesday's topic covers severe weather, lightning and hail. Beltrami County is no stranger to severe weather and has experienced significant wind events. Thunderstorms can produce straight-line winds over 100mph and can cause tornadolike damage. Lightning can kill. If you can hear thunder, you are close enough to be struck by lightning. If you are outdoors

remember the saying, "When thunder roars, go indoors!" Hail can also be destructive, ruining crops and causing damage to homes and vehicles. Hail as large as baseballs has hit areas of Beltrami County in recent years.

Flooding kills more people annually than other weather events. Wednesday is dedicated to flood awareness. As little as six inches of fast flowing water can knock you off your feet. Twelve inches of flowing water can float vehicles. Of the deaths related to flooding, many were caught in vehicles and the majority died at night. If you encounter flooded roadways, turn around, don't drown. You don't know how deep the water is or if the road has washed out.

Thursday, April 10, 2025 is tornado drill day. Two simulated tornado warnings will be conducted. The first is scheduled for 1:45pm to allow schools, offices and other institutions to practice their tornado plans. A second is scheduled for 6:45pm to allow families to practice their plan at home as well as second shift workers. If severe weather is possible on this day, the drill will be cancelled.

While Minnesota isn't known for its hot weather, dangerous heat does occur. During hot weather, drink plenty of water and avoid outdoor activities. Heat related injuries and ailments are emergencies. Some symptoms of heat related illness include cool, moist, pale or flushed skin; heavy sweating; headache; nausea; dizziness; weakness and exhaustion. Vehicles act like greenhouses, especially on sunny days. It only takes minutes for cars to warm to deadly temperatures. Never leave children or pets in vehicles on warm days.

What to Do with the Existing Iail

Now that the new jail design is complete and construction is scheduled to start in April, the D&O (design and operations) committee has shifted its focus to determining what should be done with the existing jail. We know that this facility was built in 1988, so it is around 37 years old. We also know that this facility does not meet current MN Department of Corrections regulations due to existing layout and functionality. And lastly, we know that if this facility is to be used in the future, there will need to be significant upgrades in building infrastructure.

With that being said, the D&O committee determined that it needed more information about the existing jail in order to provide a fiscally responsible recommendation to the County Board on future use and operations of this facility. On February 4, 2025 the County Board approved a contract with Kraus Anderson Construction Company to conduct an FCA (facility condition assessment) for the purpose of

determining the current condition of the facility and equipment, what equipment upgrades are needed now and into the future, and estimated costs to update facility and equipment to possibly continue to operate this building in some capacity into the future.

Information obtained from the FCA will help identify which of the following may be a viable and fiscally responsible option for the County to move forward with. The options currently being reviewed are as follows:

- Reuse and or repurpose the facility.
- Partial demo of facility (reuse part of facility for sally port inmate transfer to courthouse).
- A complete demo of facility.

The FCA process has started and is expected to be completed within the next few months. The results of this assessment will be instrumental to architects as they work to determine the best methods of transfer of inmates to and from the courthouse.

Federal enforcement begins May 7, 2025

Minnesotans 18 years of age or older will not be able to use their standard driver's license or identification card to board domestic flights or enter certain federal facilities. Instead, they will need one of three options:

- Minnesota REAL ID driver's license or identification card.
- Minnesota Enhanced driver's license or identification card.
- Other federally approved forms of identification.
