

# MOVIL MAZE RECREATION AREA SHELTER PERMIT

(Page 1 retained by Permittee, Page 2 retained by NRM Staff)

**Rental Season:** April 1 – November 30. *Reservations can only be made in the current calendar year; no advanced reservations will be allowed.*

**Fees:** \$75.00 per day for the shelter  
\$100.00 deposit. Please write two separate checks for fee and deposit.

The deposit will be promptly returned upon satisfactory inspection. If the shelter is not cleaned or damage has occurred, your check will not be returned, and you will be required to pay for any additional damages exceeding the deposit.

**Entry:** The shelter door is secured with a digital combination lock. **It is the responsibility of the permittee to contact NRM prior to their reserved date for the combination.** Office hours: Monday - Friday from 8:00 am - 4:30 pm, closed on weekends and major holidays. Phone: 218-333-4210.

## **Shelter Rules:**

- The shelter is available only on your reserved date. **Entry before the rental date is not permitted.**
- **Do not prop open the doors;** it can damage the closing mechanism.
- Only freestanding decorations are allowed. **No adhesives, tape, nails, pins, tacks, or staples** may be used on any portion of the shelter.
- Return tables to their original locations and wipe them off. **Do not remove tables from the shelter.**
- **Sweep the floors and clean up spills.**
- **Close and lock all windows and doors** before leaving.
- Take all garbage with you; Movil Maze Recreation Area is a carry-in, carry-out facility. Anything left becomes property of Beltrami County.
- Pets are not allowed in the shelter. Clean up pet waste immediately in mowed and maintained areas. Do not use vault toilets for disposal.
- Parking is first come, first served. Reserving parking spots is not allowed.
- The day use area is open to the public. Renting the shelter does not grant additional privileges.
- Disorderly conduct is prohibited. Do not make noise that alarms or disturbs others. Be courteous to day use area visitors.
- Shelter and day use area closes at sunset.
- No overnight camping is allowed in the shelter area or day use area.
- All other Developed County Parks and Recreation Area Ordinances and rules are in effect and must be followed.
- Site is patrolled by the Beltrami County Sheriff's Office.
