# News and Highlights

Future Beltrami County Adult Correction Center

The new 243-bed Adult Corrections Center will be built at 815 Pioneer St. SE, on donated land near Bemidji's Industrial Park. The facility will incorporate modern security measures and rehabilitative programs aimed at reducing recidivism. Inmates will have access to mental health care, substance abuse treatment, and reintegration programs, helping them transition back into society more successfully.

The project is being funded through a 0.625% local option sales tax, which was approved by Beltrami County voters. The first phase of the project, which includes preliminary design services, has already been completed, with Klein McCarthy Architects contracted to oversee the design and construction.


Construction began in April 2025 with completion expected by April 2027. The new facility is expected to bring economic benefits to the region, creating jobs and improving public safety.

As construction progresses, the Design and Operations Committee continues to meet regularly and is now doing so onsite. Beltrami County officials will continue to engage with the public, ensuring transparency and community involvement in the development of the new jail. Residents can stay updated on the project through official county announcements and local news sources.

While a ceremonial groundbreaking took place last fall, actual construction didn't start until this spring. Winters in Minnesota can be challenging and waiting had substantial cost savings by not requiring additional expense for heating and sheltering of the construction site. Now that spring is here, construction is in full force.

# **Emergency Shelter Management Training**

After the Fire - Two Years of Planning for Success



After two years of planning, Beltrami County partnered with the American Red Cross to conduct a highly successful shelter management training and exercise for the region. The training and exercise identified proficiencies/deficiencies and helped determine equipment that needs to be procured. Beltrami County is required to conduct a Hazard Vulnerability Analysis (HVA) identifying various hazards that could impact our communities. Two years ago, the Public Health and Emergency Management Departments began co-planning an exercise focused on our top hazard: wildfire.

Leading up to the exercise, several planning sessions were held including tabletop exercises focused on discussion-based, simulated disasters. This process brought many stakeholders together from law enforcement, public health, emergency management, health and human services, fire service, emergency medical services, public works, energy partners and the private sector. This concept is referred to as whole community planning and all-hazards planning.



Through the exercises, the need for shelter training in Beltrami County surfaced. Prior to the devastating Los Angeles wildfires, the planning team had already set the scenario of a wildfire that displaced hundreds of residents. The unfortunate events in California highlighted how much of a possibility that is, especially in Beltrami County. Not only did the HVA identify the top hazard as wildfire, but it has also been the most frequently occurring event, outside of extreme winter weather.

On April 22 and 23, 2025, the team arrived at the Sanford Center in Bemidji to set up for the training and exercise. The American Red Cross conducted the training after a welcome from Public Health Director Amy **Bowles and Emergency Management** Director Christopher Muller. Over 100 volunteers and staff from as far away as Kittson County and Stearns County were in attendance for the training. The diverse attendance is essential for quality planning in the event of a disaster because resources may be competitive and limited, requiring mutual aid. Some of the topics covered were reception, registration, opening a dormitory, feeding, and health needs.

The second day was a full-scale exercise that built off the scenario in the training. However, this time there were people who needed sheltering and emergency services that walked through the doors. Over 100 volunteers participated in the simulated disaster where wildfire scorched hundreds of acres and burned numerous homes. During the exercise, many situations that could present themselves in a real shelter were injected.





One family reported that three of their children were missing when the flames swept through, burning their home. Law enforcement responded to take the report and work with the fire services to try to locate them. As the exercise progressed, they were later located safe in a tree house that was spared by the flames. There were also two overdoses in the shelter that required the administration of Narcan. Another client indicated they were a registered predatory offender. These scenarios were quickly mitigated by shelter staff.

Lunch during the exercise was originally going to be a buffet but was replaced with a meal that would be expected at a shelter. There was no self-serving and all the meals were boxed and safely distributed to the attendees. Efficiently feeding over 100 people in minutes, this training replicated mass care services during disasters. Beltrami County, along with the many neighboring agencies that participated, is better equipped to respond to sheltering needs in the community as a result of this event. Beltrami County Emergency Management and Public Health Emergency Preparedness intend to continue this partnership, enhancing the resiliency and preparedness of the County.

The planning team would like to express gratitude to the American Red Cross for sharing all their talents and resources. This exercise wouldn't have been possible without all the volunteers who took time out of their day to play the roles of evacuees and clients.



 Located ten minutes north of Bemidji, Movil Maze Recreation Area offers over 17 miles of trails. - Wilton Hill Recreation Area is located south of Wilton and is a great place to explore. There are no current amenities, but there are roads and old forest trails to hike, run, or bike on. The gravel pit area is open to motorized vehicles.

### FBO Update April-May 2025

Construction has begun on the renovations for the Fixed Base Operation (FBO) operated by Bemidji Aviation. The FBO is getting new carpet, paint, bathrooms and a new layout to better serve pilots and customers that utilize the FBO in Bemidji. Bemidji Aviation FBO provides a host of services including overnight and monthly hangar rentals, fuel, pilot lounge, pilot gear, flight services and charter services. The project should be completed sometime next month so stop in and see Bemidji's new and improved FBO!

### Airport Rescue and Firefighting

The Bemidji Regional Airport owns and operates the Airport Rescue and Firefighting Program (ARFF). Almost all of the full-time and part-time employees are fully certified ARFF trained specialists who have completed at least a week long course in aircraft firefighting along with continued education throughout each year. All employees who work as ARFF specialists are required to attend all trainings and meet all requirements set forth by the FAA (Federal Aviation Administration) and the Bemidji Regional Airport.

Along with the training, we also own and operate our own ARFF vehicle, a 2020 Rosenbauer Panther 4x4, call sign Crash 9. The truck meets and exceeds the required airport ARFF index rating. Bemidji Airport takes care of all maintenance, inspections and testing of Crash 9 along with practicing with the truck for monthly trainings so the employees are freshly trained to respond to any aircraft emergency at any time.

### **Experimental Aircraft Association**

### **Frequently Asked Questions**

Does the Bemidji Regional Airport host tours?

Yes we host tours at the airport by request. Tours usually consist of the FBO, the terminal, the ARFF (Aircraft Rescue and Firefighting) program, and the airport maintenance shop where the snow removal equipment is based. Most of our tours consist of school groups but we will host any tour by request.

## When should I show up for my flight out of Bemidji?

Baggage check ends 45 minutes before departure, so we recommend that passengers arrive at least 1 to 1 ½ hours before their flight to check bags and get through security.

#### How much does parking cost at Bemidji Regional Airport?

The short answer is it's free! We have short term (7 days) and long term (60 day) parking along with 1 hour pick-up parking and general aviation parking at Bemidji Airport. All of our parking is free.

### Can I learn to fly at Bemidji Airport?

Yes you can! Bemidji Airport is host to two flight schools, Bemidji Aviation and Barnstormers (who just won an award from AOPA for Distinguished flight school in their region). Both schools have multiple planes and instructors who can teach you the basics all the way up to advanced skills and everything in between.

### Notices:

## Brian Olson Solid Waste Division Director **Transfer Station Improvements in 2025**

Construction is scheduled to begin in July and is expected to be completed by November 1, 2025 for planned improvements at the Bemidji and Blackduck Solid Waste Transfer Stations.

Originally built in 1978 and formerly known as the Candy Factory, Building A of the Bemidji Transfer station (751 Industrial Park Dr. SE) had undergone several remodels prior to the County purchasing it in 2017. It currently houses the Solid Waste Division staff offices, an Employee break room, maintenance bay, and Reuse Recycle area. In April 2025, the building received a new roof to address ongoing leaks, along with the addition of gutters and ice/snow cleats.

Further improvements planned for Building A include:

- Replace exterior steel siding with insulated foam panels to improve energy efficiency
- Install a car port/canopy over roll-off containers in front of the Transfer Station to enhance safety, reduce stormwater impacts, relocate flammable materials away from the building, and improve traffic flow
- Remodel the office area to meet current code requirements
- Replace approximately one-third of the non-pervious surfaces that disrupt traffic flow and present safety concerns, including relocating and burying existing power lines



Planned improvements at the self-service Blackduck Transfer Station (33003 Hwy 72 NE) include:

• Install car port/canopy over the existing concrete slab to improve safety, reduce storm water impacts and provide shelter for customers during inclement weather.

# Community Health Assessment

What is the CHA?

CHA stands for **Community Health Assessment.** A CHA is a comprehensive process where we collect and analyze data about the health of our community. This includes looking at things like chronic disease rates, access to healthcare, mental health needs, and social factors like housing, income, and education. The goal is to gain a full picture of our community's health status and the factors that influence it.

This assessment is done with input from residents, healthcare providers, community leaders, and local organizations—so it reflects both data and lived experience. In 2024 the Beltrami County CHA CHIP work group conducted a simple community survey to gather input from the residents. We wanted to know:

- What are the top three (3) most important factors when you think of a "healthy community?"
- What top three (3) factors do you feel are positively affecting the health of Beltrami County?
- What top three (3) factors do you feel are negatively affecting the health of Beltrami County?
- If Beltrami County were to have a community emergency, what top three emergencies would you feel most prepared for?

What is a CHIP?

CHIP stands for **Community Health Improvement Plan.** Now that we understand our community's health needs through the CHA and hearing from the community, we are using that information to create a CHIP. This is a strategic plan that outlines specific goals, actions, and partnerships aimed at improving the health of our residents over the next five years.

The CHIP is driven by collaboration. It brings together public health agencies, hospitals, schools, nonprofits, and community groups to work toward shared goals—like reducing food insecurity, improving mental health services, or increasing access to preventive care.


Together, these tools help communities like ours identify our most pressing health needs and develop strategies to address them.

The CHA and CHIP process ensures that health priorities are based on actual community needs and that resources are used effectively. It also creates accountability, as progress is tracked and shared with the public.


When the whole community is involved in identifying challenges and solutions, we build a stronger, healthier future—together.

In May, the Public Health Department participated in the All-County Employee Annual Safety Training by providing employees with knowledge on how to use an AED. An AED increases the survival rate from cardiac arrest by 60%! An AED is designed for use by laypeople with little or no training by giving voice commands on application and when to deliver a shock. Public Health is available to bring mannequins and AED trainers to health fairs to support readiness and respond to emergency events. # **Beltrami Area Service Collaborative**

### Elevating Youth Voice, Equity, and Prevention

The Beltrami Area Service Collaborative (BASC) is excited to share highlights from our ongoing work to support youth, families, and cross-agency collaboration in Beltrami County. In the first quarter of 2025, we've advanced several key initiatives focused on prevention, equity, and youth engagement.

### CANRenew Grant Application: Centering Youth Voice

BASC applied for the CANRenew Community Restoration Grant to support a substance use prevention campaign shaped by youth perspectives. The initiative aims to reduce stigma and promote healthy choices through culturally relevant, peer-informed messaging. By creating space for youth voice, the campaign empowers students to help design materials that resonate with their peers and reflect community values. collaboration, update screening tools, and enhance coordinated responses to improve long-term outcomes.

### ERD Initiative: Addressing Disparities

We are proud to help lead Beltrami County's participation in the Eliminating Racial and Ethnic Disparities (ERD) initiative, also in partnership with RFK. This work focuses on reducing racial and ethnic disparities in youth-serving systems—especially for Indigenous and BIPOC youth—through data-driven strategies and authentic community engagement.

### CSUP Grant Collaboration with Public Health

As part of the state's Cannabis and Substance Use Prevention (CSUP)

### **Revitalizing Dual Status Youth Programming**

BASC submitted a Dual Status Youth Planning Grant through the Minnesota Department of Public Safety to revitalize our current program for youth involved in both the child welfare and juvenile justice systems. Through technical assistance from the RFK National Resource Center for Juvenile Justice, we aim to strengthen system Grant, BASC is working with Beltrami County Public Health to elevate youth voice in shaping prevention efforts. We are engaging 11th and 12th grade students from area schools through surveys and open invitations to share their ideas. Their input will guide outreach materials including presentations, brochures, and radio ads.

BASC remains committed to collaborative, culturally responsive solutions that reflect the voices and needs of our community.

Together, we are building a healthier, more equitable Beltrami County.

# **Cannabis Businesses in Beltrami County**

The State of Minnesota legalized adult-use cannabis in 2023 and created Minnesota Statutes Chapter 342 which established the regulatory framework for this new industry. The Red Lake Band of Ojibwe opened the first cannabis retail business in the State of Minnesota in August of 2023, shortly after it became legal. In late 2024, Beltrami County passed an ordinance regulating cannabis businesses in compliance with MN Statutes. Between Minnesota legalizing cannabis use and today, there has been a lot of chaos and confusion regarding who will get a State license to operate a cannabis business and when those licenses will be issued. Well, it seems like that has all been ironed out as the State of Minnesota has announced plans to conduct the lottery for cannabis business licenses on June 5<sup>th</sup> and begin the process of issuing licenses and assisting businesses with the registration process with cities and counties. No State of Minnesota licenses have been issued yet to operate a cannabis retail business so the tribal retail stores continue to be the only operating retail stores in the State.

It seems like we have been hearing about this for a long time now, and we have, but it seems a bit more real now as Beltrami County issued the first conditional use permit for a retail cannabis business just north of Bemidji at the April Planning Commission meeting. Beltrami County did set a maximum number of retail businesses that can be registered by the County at 4 (1 for every 12,500 residents) so you won't notice a lot of different cannabis retail businesses located around the County but you will likely see a few of them. You may also start to see some businesses begin operation for cannabis production, packaging, manufacturing, etc... but all of the private businesses will need to first receive a conditional use permit from the County (or follow local regulations if outside of Beltrami County's jurisdiction), register with Beltrami County (or other local government), and receive their State of Minnesota license to operate the businesses will affect our local economy, tourism, businesses districts, etc.... but I am optimistic that the new businesses in this new industry will prove to be great neighbors and another economic opportunity for local entrepreneurs to contribute to our local economy.

If you are considering starting a cannabis business in Beltrami County, I encourage you to reach out now to your local zoning authority to discuss these plans and potentially start the process for the permitting and any other approvals that will be required prior to opening.
